
Minutes for Bath Astronomers Annual General Meeting

Present at the Museum: Attendees were not recorded in full but included Simon Holbeche, Prim Pike, Jade Preedy, Julia Matthews, Martin Farrell, Stephen MacGillivray, Kathryn Drury & Jenny Bowden.

On-Line/Zoom Attendance: Attendees were not recorded in full but included Roger Hyman, Jonathan Hall, Charles Draper, Ben Luger, Pete Morris, & Terry Morrow.

- 1. Simon H welcomed all to the meeting which marked the fourth anniversary of the reconstituted society, and he outlined the agenda and proceedings for the A.G.M. including changes to the constitution the nomination and election/re-election of coordination members.
- 2. The summary of BA activities over the year was undertaken as a slide show of photos from outreach and observing events over the prior 12 months. It included combined events with the Herschel Museum and with Bath Abbey, visits to schools, social events, observatory visits, public outreach, Solargazing, and icy telescopes under the stars.
- 3. The minutes of the previous AGM held on 30th November 2022 were agreed as being a fair and accurate record and no further comments were received. There were no outstanding actions or matters arising.
- 4. SH showed the change in balance over the year and the investments in new assets including two refractors, one energy rejection filter, one Herschel wedge, one Daystar Quark, one AVX mount for loan telescope, and two SkyMax 127 GTi for loan. The investment bolsters both the loan scheme for members and our Solargazing outreach capability. Revenue continues from both membership subscriptions and partnerships with Bath Abbey and the Herschel Museum as well as a small component for the minimum hire charge of the planetarium. The total money in the bank on 15th Oct was £2,846.26. Four items contribute to the higher expenditure in October: Meteorites for outreach £440, replacement deep cycle batteries at Monkton £303, a new shroud for 16" Skywatcher £137, and BRLSI Room hire £139.



An annual set of accounts was not prepared or presented this year.

(Chair's Note: Following the Annual General Meeting, Jade Preedy and Jonathan Hall are to be removed as signatories to the Bath Astronomers' Metro Bank accounts, both current and savings. Their online access is to be revoked. Martin Farrell (Secretary) is to be added as a signatory to the Bath Astronomers' current and savings Metro Bank accounts. Martin is to be given online access to these accounts. Simon Holbeche's access to the Metro Bank accounts remains unchanged. The practices of not issuing bank cards and allowing just one signatory per transactions remain unchanged).

5. The membership report reflected a steady growth in overall numbers from the year's starting point of a 92 finishing the year at 110 (as of 25th October 2025) - a net increases of 18. One question was raised on the attrition and it was explained the situation was akin to 2 steps forward, 1 step back with 1 leaver for every couple of people that joined.



No further questions on financial or membership matters were received from attendees and therefore the financial and membership summary reports were accepted.

- 6. The proposed changes to the constitution were outlined and comments requested. Attendees confirmed they had noted the changes. The vote in the Herschel Museum was two abstentions and all others in favour. The changes were approved.
